



WHEREAS the AUTHOR has immense confidence in the parties of the SECOND PART and is appointing them as the TRUSTEES of this TRUST hereby declared, and the PARTIES OF THE SECOND PART in token of accepting the confidence reposed in them join the AUTHOR in execution of this DEED OF DECLARATION OF TRUST; and

NOW THIS DEED OF DECLARATION OF TRUST, THEREFORE, WITNESSES AS FOLLOWS:

1. The Author of the TRUST does hereby declare a sum of Rs. 10,000/- (Rupees Ten Thousand Only) contributed by him as TRUST PROPERTY and hereby transfers, assigns, conveys and delivers unto the TRUSTEES and the TRUSTEES hereby acknowledges to have, own, hold and be in possession of the same in TRUST and (which term shall mean and include not only the said sum of Rs. 10,000/- (Rupees Ten Thousand Only) as TRUST PROPERTY, under these presents but also the additions and accretions to the same by way of donations, surplus, further gifts, endowments etc., and all the investments for the time being representing the same) for certain specified educational & charitable objects and accordingly the TRUSTEES hereby declare that they shall continue to hold the TRUST funds in TRUST for these objects and purposes in accordance with the terms and conditions contained in these presents.
2. The Trust Shall be called "**SRI SRINIVASA TRUST**" and shall have its registered office at No 302/148/A1, Bandahalli Road, Vinayaka nagara, Hanur, Chamarajanagar - 571439 in the first instance or at any other place as decided from time to time by the Board of Trustees.
3. The Trust shall be public charitable trust for the benefit of people in India irrespective of race, religion, caste, community or creed.
4. The TRUSTEES hereby declares the Trust to be IRREVOCABLE, they further declare that they neither reserve any right to revoke the trust nor receive any benefit either directly or indirectly from the trust under any circumstances except as permissible under this deed.
5. The Trust shall be constituted and administered in accordance with the terms of this Deed of Trust and the rules & regulations framed hereunder.



6. The Trust also aims to carry out cultural, social and charitable activities.
7. **PROPERTY OF THE TRUST:**
- a. A sum of Rs. 10,000/- (Rupees Ten Thousand only) donated by the Author this day and shall form the corpus of the Trust.
- b. Such contributions, donations, grants, endowments, settlements, made by the public, Government, institutions, individuals both local and foreign and the like for the advancement and implementation of the objects and purpose of the trust.
- c. Such acquisitions and accretions to the estate of the Trust as may be made by the board of the trustees;
- i. Any Properties movable or immovable, that may be acquired by the trust either by purchase or otherwise;
- ii. All additions and accretions of the Trust fund;
- iii. All sums and assets which by and means become the property of the Trust.
- d. All licenses, properties etc. which shall be transferred or acquired from other trusts and societies.
8. **AIMS AND OBJECTS OF THE TRUST:**
- Without prejudice to the generality of the provisions of this instrument of the Trust, the aims and objects of Trust shall be the following:-
- a. To establish, own, run, takeover or manage and maintain or contribute towards establishment, and maintenance of pre-schools, kindergarten schools, play schools,

- d. The Board of Trustees shall collect the income of the Trust fund and shall there from pay in the first instance all the costs, charges and expenses of the Trust and shall hold the balance of the income of the Trust fund for the objects of the Trust;

Governing Board of the institutions established by the said Trust which may be amended from time to time. The Governing Board may for the purpose of achieving its aims and objects, take the services of professional individuals, bodies, companies to run any of its institutions, etc., and for the said purpose, execute contracts and make payments to such professional bodies, individuals to help run institutions established by the Trust;

- r. The Board of Trustees shall do and cause to be done all such lawful things as are in accordance with or conducive to the attainment and pursuit of the aims and objects of the Trust;
- s. The Board of Trustees shall ensure that every property of the Trust, movable or immovable shall be held in the name of the Trust;
- t. Every resolution or decision of the Board of Trustees unless unanimous shall be taken by a majority vote of the Trustees present and voting and in the case of equality of votes, the Chairman shall have a casting vote. The Board of Trustees may pass any resolution by circulation if it is so required. The quorum for the meeting shall be simple majority of total strength of the trustees.
- u. The Board of Trustees shall be entitled to frame rules and regulations for the conduct of the business and administration of the Trust and for carrying out its objects and for the maintenance and conduct of its projects, its activities and the facilities provided therein, and to alter, amend or vary such rules and regulations from time to time as they may deem proper. 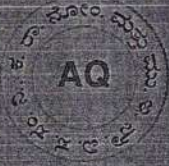

The Trustees under these presents shall be chargeable only for such moneys as they shall respectively actually receive, notwithstanding their signing any receipt or receipts for the sake of conformity and they shall be answerable and accountable only for their own acts, receipts, neglects and defaults and not for those of others or for any banker or other person with whom or in whose hands any of the Trust moneys may be deposited or for any loss, unless the same shall have happened through his/her/their own wilful default, or which shall be attributed to him/her/them respectively;
- y. The Board of Trustees consider that the objects of the Trust will be better achieved if the income of the Trust is exempted under the Income Tax Act, 1961. In cases however, where a particular clause of this Deed of Trust has been inadvertently clothed in language capable of an interpretation in conflict with the relevant provisions, the clause or clauses shall have restricted meaning or be null and void so that the relevant provisions of the Income Tax Act, 1961 will always have the overriding effect;
- z. The Board of Trustees shall only by unanimous decision of the Trustees present, have the power to amend, alter, add or delete any of the clauses contained herein above, provided that no change, amendment, alteration, addition or deletion shall be made which may prove to be repugnant to the provisions of the Income Tax Act 1961, and more specifically to sections 2(15), 10, 11, 12, 13 and 80G of the Income Tax Act 1961 as amended from time to time. No amendment to the trust deed shall be carried out without the prior approval of the Commissioner of Income Tax;
- aa. The Board of Trustees shall interpret all provisions of this Deed of Trust as well as any rules and regulations that may be framed in the future by the Board of Trustees. Its decision shall be final and binding;

a. The Founder, SRINIVASA NAIDU V shall be the first Chairman and he shall be Chairman for Life or till he relinquishes the post. Thereafter, the Chairman for this TRUST shall be elected by a majority of the Board of Trustee from amongst themselves for such period as specified at the time of his/her appointment. The chairman shall have the following the powers, duties and functions apart from above mentioned-

- i) To Supervise and guide the overall activities of the Trust and to ensure fulfilment of its aims and objectives.
- ii) To be Responsible for the smooth working of the trust/Board of Trustees.
- iii) To admit or discharge members to the Trust on the approval of Board of Trustees.
- iv) To Perform all such duties and functions as specifically entrusted/delegated by the Board of Trustees/Trust.
- v) To execute legal documents, papers affidavits, applications in connection with fulfilment of aims and objectives of the Trust. The information of which to be given to Board of trustees in the Subsequent meeting.

14. MEETINGS:

The Board of Trustees shall hold meetings at least once in six months, notice of such meetings shall be given at least a week in advance. Decisions will be taken as far as possible by consensus and in the event of any difference by simple majority. Where the votes are equal, the Chairman shall have a casting vote. Quorum shall be simple majority of the strength of the trustees. Resolution by circulation is permissible.

15. THE TERM OF A TRUSTEE:

- d. On absence from India for a continuous period of more than 2 years, without leave from the Board of Trustees;
- e. On retirement on the Trustee's own volition expressed in writing, with at least seven clear days' notice to the Board of Trustees. However, in the event that the number of Trustees on the Board of Trustees is not more than three, in that event, on receipt of notice of resignation of any one of the Trustees, any one of the Trustees shall call for a

meeting of the Board of Trustees and the Board of Trustees shall by majority vote elect any person as a Trustee to fill such vacancy, and the person so elected shall be deemed to have all the powers of a Trustee;

- f. On being convicted in crimes involving moral turpitude;
- g. On removal by the Board of Trustees.

16. THE REMOVAL OF A TRUSTEE:

The Board of Trustees may, by unanimous vote of all the Trustees present except the Trustee proposed to be removed, remove any Trustee, permanent or otherwise, from office after finding the Trustee proposed to be removed guilty of serious misconduct in relation to or concerning the Trust estate or Trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in writing, the continuance of the Trustee proposed to be removed as Trustee is desirable, keeping in view the objects of the Trust and other related or connected matters, provided however, that no conclusion of such guilt shall be arrived at without giving the Trustee proposed to be removed a full and fair opportunity of explaining his/her conduct and/or the charges levelled against him/her for his/her removal. And the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called into question anywhere.

17. ACCOUNTS AND AUDIT:

- a. The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.
- b. Generally, the year of account shall be the financial year commencing from 1st April and ending 31st March. The same can be changed to such other term as may be prescribed/amended in Income Tax Act or any other law in force or as may be decided by the Board of Trustees.
- c. The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than twelve months from the end of the preceding year of accounts.
- d. The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the board of Trustees and the audited statement of accounts together with Auditors' report shall be laid before the Board of Trustees for approval.

18. POWER TO ALTER RULES AND REGULATIONS:

- The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. Any amendment to the Trust Deed will be carried out only with the unanimous decision of the Trustees. Any amendment to the objects of the Trust under this Trust Deed will be carried out only with the approval of the Commissioner of Income Tax.
- No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 10, 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time.

19. ADVISORY GROUPS:

- Any Advisory Group so appointed by the Board of Trustees in terms of Clause 10 (p) shall examine and report on the matters referred / delegated to it.
- The members of any Advisory Group shall not exceed seven and shall include at least one of the Trustees.
- The Trust can constitute any number of Advisory Groups depending on requirement, and wind up the Groups after their purposes are served.

20. APPLICATION OF INCOME AND TRUST FUND:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section 13(1) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

21. REMUNERTION AND INCOME:

If at any time any Trustee acts as whole time office bearer of the Trust or renders special service, the trustees may at their discretion pay such remuneration or allowance to him within such limits as they may think proper and they are also entitled to receive out of pocket expenses incurred by them in the course of discharging the functions of the Trust.

22. RECORD

The Board of Trustees will cause a record to be kept of investments and disbursements besides a minutes book recording all resolutions and proceedings for every meeting duly confirmed at the next meeting and attested by the Chairman.

23. SUITS:

The Chairman of the Trust is authorized to sue or to be sued on behalf of the Trust.

24. INDEMNITY:

Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by own negligence and also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust amended by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

25. IRREVOCABILITY :

The Trust shall be an irrevocable public charitable and educational trust for the benefit of all children belonging to whatever community irrespective of Caste, Creed or Religion, but in the event of any circumstances in which it is decided to dissolve the Trust, the Trust property after meeting all liabilities shall be amalgamated with or transferred to some other institution engaged in similar objects and functioning without motives of profit and eligible for exemption under section 10 (23C) or section 11 of the Income Tax Act, 1961 as a public charitable institution which enjoys recognition and exemption u/s 80 G of the Income Tax Act 1961 with the approval of the Commissioner/Chief Commissioner of Income Tax/Director of Exemptions concerned and with the permissions of the Charity Commissioner if required.
